



## **UK Stewardship Code**

Stewardship is defined as “the responsible allocation, management and oversight of capital to create long-term value for clients and beneficiaries leading to sustainable benefits for the economy, the environment and society.” Under COBS 2.2.3 of the FCA Handbook, Tellsons are required to make a public disclosure in relation to the nature of our commitment to the Stewardship Code, which was published by the Financial Reporting Council (‘FRC’) in July 2010 and amended in September 2012 and January 2020. Where we do not commit to the Code we are required to disclose our alternative investment strategy.

The Code aims to enhance the quality of engagement between institutional investors and companies to help improve long-term returns to shareholders and the efficient exercise of governance responsibilities. It sets out good practice on engagement with investee companies and is to be applied by firms on a "comply or explain" basis. The FRC recognises that not all parts of the Code will be relevant to all institutional investors and that smaller institutions may judge some of the principles and guidance to be disproportionate. It is of course legitimate for some asset managers not to engage with companies, depending on their investment strategy, and in such cases firms are required to explain why it is not appropriate to comply with a particular principle.

The Code does not prescribe a single approach to effective stewardship. Instead, it allows organisations to meet the expectations in a manner that is aligned with their own business model and strategy. The investment market has changed significantly since the publication of the first UK Stewardship Code. There has been significant growth in investment in assets other than listed equity, such as fixed income bonds, real estate and infrastructure. These investments have different terms, investment periods, rights and responsibilities and signatories will need to consider how to exercise stewardship effectively in these circumstances. Environmental, particularly climate change, and social factors, in addition to governance, have become material issues for investors to consider when making investment decisions and undertaking stewardship. The Code also recognises that asset owners and asset managers play an important role as guardians of market integrity

and in working to minimise systemic risks as well as being stewards of the investments in their portfolios.

Tellsons Investors invests the Endeavour Fund across global public bond and equity markets, including UK equities. The Code is therefore relevant to some aspects of the Firm's activities. While the Firm supports the objectives that underlie the Code, the Firm has chosen not to commit to the code, but to reaffirm our commitment to all management principles and operational policies which enshrine the most sustainable long term business outcomes for all stakeholders, including but not limited to shareholders, employees, customers, and communities.

We determine our approach to stewardship on a case by case basis, taking into account our duties to the funds that we manage and management policies that will lead to the most favourable outcome for the commercial and social value of our investee companies in the long term. We look for these values to be mutually enhancing rather than in any way mutually exclusive in our investments.

Furthermore, the Firm takes a consistent approach to engagement with issuers and their management in all of the jurisdictions in which we invest to the extent our modest resources make it possible. As a consequence, the Firm does not consider it appropriate to commit to any particular code relating to any individual jurisdiction.
